**ARTICLES OF INCORPORATION
OF
OAKLAND PARK OWNERS ASSOCIATION, INC.**

The undersigned hereby executes these Articles of Incorporation for the purpose of forming a not-for-profit corporation under Chapter 617.0202 Florida Statutes.

ARTICLE I
NAME

The name of the corporation shall be **OAKLAND PARK OWNERS ASSOCIATION, INC.**, a not-for-profit Florida corporation ("Association").

ARTICLE II
PURPOSE

The purpose and objective of the Association shall be to administer the operation and maintenance of the Surface Water Management System within Oakland Park Subdivision. Such activities shall be consistent with the provisions of Broward County Surface Water Management License Number 3-20-49-42. The performance of the acts and duties herein imposed shall also be in accordance with the terms, provisions, covenants and restrictions contained in these Articles, the Declaration of Covenants and Easements of Oakland Park (the "Declaration") as recorded in the Public Records of Broward County, Florida and the Bylaws (the "Bylaws") of this corporation. The Association shall be conducted as a Florida not-for-profit corporation. The terms used in these Articles shall have the same meaning as set forth in the Declaration.

ARTICLE III
POWERS

The Association shall have the following powers:

A. All of the powers and privileges granted to corporations not for profit under the law pursuant to which this corporation is chartered, and all of the powers and privileges which may be granted unto said corporation or exercised by it under any other applicable laws of the State of Florida.

B. All of the powers reasonably necessary to implement and effectuate the purposes of the Association, including, but not limited to:

1. Making and establishing reasonable rules and regulations governing the use of the Surface Water Management System in Oakland Park as said terms may be defined in the Declaration.

2. Levying and collecting assessments against members of the Association to defray the common expenses of the community as provided in the Declaration and in the Bylaws of this Association which may be hereafter adopted.

3. The power to operate, maintain and manage the Surface Water or Stormwater Management System(s) in a manner consistent with County requirements and applicable rules and shall assist in the enforcement of the restrictions and covenants contained herein. The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the Surface Water Management System. The assessments collected by the Association shall be used, inter alia, for the maintenance and repair of the Surface Water Management System included but not limited to work within retention areas, drainage structures and drainage easements.

4. Contracting for maintenance of the Surface Water Management System.

5. Enforcing the provisions of the Declaration, these Articles of Incorporation and the Bylaws of the corporation which may be hereafter adopted, and the rules and regulations governing the use of the Easements as the same may be hereafter established.

6. To exercise, undertake and accomplish all of the rights, duties and obligations which may be granted to or imposed upon the corporation pursuant to the Declaration.

ARTICLE IV **MEMBERS**

The qualifications of the members, the manner of their admission to membership and termination of such membership, and voting by members shall be as follows:

A. Every Parcel Owner which is subject to assessment shall be a member of the Association. Membership shall be appurtenant to and may not be separated from ownership of any Parcel which is subject to assessment.

B. Membership shall be established by the acquisition of fee title to a Parcel in the community or by acquisition of a fee ownership interest therein, whether by conveyance, devise, judicial decree or otherwise and the membership of a party shall be automatically terminated upon being divested of all title in and to a fee ownership interest in any Parcel except that nothing herein contained shall be construed as terminating the membership of any party who may own two (2) or more Parcels, so long as such person shall retain title to at least one Parcel.

C. The interest of a member in the funds and assets of the corporation cannot be assigned, hypothecated or transferred in any manner, except as an appurtenance to his Parcel. The funds and assets of the corporation shall belong solely to the corporation, subject to the limitation that the same be expended, held or used for the benefit of the membership and for the purposes authorized herein, in the Declaration and in the said Bylaws.

D. Each Parcel Owner shall be a member of the Association and shall have one (1) vote on all matters brought before the Members for determination.

ARTICLE V
TERM

The corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. If the corporation shall be voluntarily dissolved, the assets shall be dedicated to a public body or conveyed to a non-profit organization having purposes as set forth in Article II hereof. Further, in the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the Surface Water Management System shall be transferred to and accepted by an entity which shall comply with Section 40C-42.027, Florida Administrative Code, and which shall be approved by the County prior to such termination, dissolution or liquidation. Further, the County is not required to take title to, or to operate any of the improvements, upon such termination, dissolution or liquidation of the corporation. This provision cannot be changed or amended without the written consent of the County. Further, in the event of termination, dissolution or final liquidation of the Association, the responsibility for the operating and maintenance of the Surface Water Management System shall be transferred to and accepted by one of the following entities: (i) local government units, including counties and municipalities, Municipal Service Taxing Units, or special taxing units; or (ii) active water control districts created pursuant to Chapter 298, Florida Statutes, drainage districts created by special act, special districts defined in Chapter 1889, Florida Statutes, Community Development District created pursuant to Chapter 1990, Florida Statutes, Special Assessment Districts created pursuant to Chapter 170, Florida Statutes, or water management districts created pursuant to Chapter 373, Florida Statutes; (iii) state or federal agencies; (iv) duly constituted communication, water, sewer, Stormwater, electrical or other public utilities; (v) construction permittees, assuming such permittee(s) have the powers required in section 12.3 of the Environmental Resources Permit Applicants Handbook Volume I; and (vi) Non-profit corporations, including homeowners' associations, condominium owner's or master associations, assuming such association has the powers required in section 12.3 of the Environmental Resources Permit Applicants Handbook Volume I.

ARTICLE VI
LOCATION, INCORPORATOR AND REGISTERED AGENT

The principal office of the corporation shall be located at 1491 Cape Sable Drive but the corporation may maintain offices and transact business in such other places within or without the State of Florida as may from time to time be designated by the Board of Directors. The name and address of the Incorporator and the initial Registered Agent is Vishnu Patel, 1491 Cape Sable Drive, Melbourne, FL 32940.

ARTICLE VII
DIRECTORS

The affairs of the corporation shall be managed by the Board of Directors. The number of members of the first Board of Directors of the corporation shall be three (3), except as may be changed from time to time by the Bylaws of the Corporation. The members of the Board of Directors shall be elected as provided by the Bylaws of the Corporation. The Board of Directors shall be members of Corporation or shall be authorized representatives, officers or employees of a corporate member of this Corporation. Any vacancies in the Board of Directors occurring before the first election will be filled by

the remaining directors. The first election of Directors shall be held within sixty (60) days from the date that the Developer transfers control of the Corporation to the Parcel owners and thereafter, election of Directors shall be held once a year at the annual membership meeting.

ARTICLE VIII OFFICERS

The Board of Directors shall elect a President, Vice President, Secretary and a Treasurer and as many additional Vice Presidents, Assistant Secretaries and Assistant Treasurers as the Board of Directors shall determine. The President shall be elected from among the membership of the Board of Directors but no other officer needs to be a Director. The same person may hold two (2) offices, the duties of which are not incompatible; provided however, that the office of the President and Vice President shall not be held by the same person, nor shall the office of President, Secretary, Treasurer, Assistant Secretary or Assistant Treasurer be held by the same person.

The affairs of the corporation shall be administered by the officers designated in the Bylaws of the corporation. Said officers will be elected by the Board of Directors at its first meeting following the annual meeting of the members of the Association and with the approval of the Board of Directors may employ a Managing Agent and/or such other managerial and supervisory personnel or entities to administer or assist in the administration of the operation and management of the community, and the affairs of the corporation, and any such person or entity may be so employed without regard to whether such person or entity is a member of the corporation or a director of the corporation.

ARTICLE IX
BYLAWS

The original Bylaws of the corporation shall be adopted by the Board of Directors and thereafter, such Bylaws may be altered or rescinded by the Board of Directors only in such manner as said Bylaws may provide.

ARTICLE X
INDEMNIFICATION

Every director and every officer of the corporation shall be indemnified by the corporation against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him in connection with any proceeding to which he may be a party, or in which he may become involved, by reason of his being or having been a director or officer of the corporation, whether or not he is a director or officer at the time such expenses are incurred, except in such cases wherein the director or officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his duties; provided, that, in the event of any claim for reimbursement of indemnification hereunder based upon a settlement by the director or officer seeking such reimbursement or indemnification, the indemnification herein shall only apply if the Board of Directors approves such settlement and reimbursement as being in the best interests of the corporation. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.

ARTICLE XI
AMENDMENTS

Any amendment or amendments to these Articles of Incorporation or to the Declaration may be proposed by the Board of Directors of the corporation acting upon a vote of the majority of the Directors, or by the members of the corporation owning a majority of the Parcel Owners, whether meeting as members or by instrument in writing signed by them. Upon any amendment or amendments to these Articles being proposed by said Board of Directors or members, such proposed amendment or amendments shall be transmitted to the President of the corporation or other officer of the corporation in the absence of the President, who shall thereupon call a special meeting of the members of the corporation for a date not sooner than twenty (20) days nor later than sixty (60) days from the receipt by him of the proposed amendment or amendments, and it shall be the duty of the Secretary to give to each member written or printed notice of such meeting, stating the time and place of the meeting and reciting the proposed amendment or amendments in reasonably detailed form, which notice shall be mailed or presented personally to each member not less than ten (10) days nor more than thirty (30) days before the date set for such meeting. Any member may, by written waiver of notice signed by such member, waive such notice, and such waiver when filed in the records of the corporation, whether before or after the holding of the meeting, shall be deemed equivalent to the giving of such notice to such member. At such meeting the amendment or amendments proposed must be approved by the seventy-five percent (75%) vote of the members owning Parcels in the community in order for such amendment or amendments to become effective. Thereupon, such amendment or amendments of these Articles shall be transcribed and certified in such form as may be necessary to register the same in the Office of the Secretary of State of

Florida; and upon the registration of such amendment or amendments with said Secretary of State, a certified copy thereof shall be recorded in the public records of Broward County, Florida within ten (10) days from the date on which the same are so registered. At any meeting held to consider such amendment or amendments of these Articles, the written vote of any member of the corporation shall be recognized, if such member is not in attendance at such meeting or represented there at by proxy, provided such written vote is delivered to the Secretary of the corporation at or prior to such meeting. Notwithstanding anything herein to the contrary, no change that would affect the Surface Water Management System shall be made without the prior written approval of the County.




