**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 617 (Not for Profit), the undersigned hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a non-profit business corporation.

**ARTICLE I - NAME**

The name of the Corporation is: DUNEDIN FIREFIGHTERS CHARITIES, INC.

**ARTICLE II - PRINCIPAL OFFICE**

## ARTICLE VIII - DISSOLUTION


