

## ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF VYZYN, INC.

Pursuant to the provisions of Sections 617.1003 and 617.1006 of the Floridan Statutes. Vyzyn, Inc., a Florida non-profit corporation (the "Corporation"), does hereby certify as follows:

- 1. The name of the Corporation is Vvzvn. Inc.
- 2. The original Articles of Incorporation of the Corporation (the "Articles") were filed on March 27, 2017, and assigned Document No. N17000003240.
- 3. Vyzyn, Inc. is a non-profit corporation and no members exist other than the Board of Directors.
- 4. The only members qualified to vote and amend the Articles of Incorporation are the officers serving on the Board of Directors.
- 4. The following amendment of the Articles of Incorporation was adopted on July 17, 2019 by two-thirds (2/3) consent of the Board of Directors who are entitled to vote, and by which is a sufficient number of votes cast for such amendment necessary for the approval thereof.
- 5. Article III of the Articles of Incorporation is hereby amended and restated in its entirety and replaced with the following:

### Article III

Vyzyn, Inc. is a faith-based (Christian) organization with a goal of providing an internet ministry blogsite displaying content regarding teachings of the Holy Bible and expanding into a social media network forum for churches in the United States. Vyzyn, Inc.'s goal is also to provide an internet network (social media) to support churches in their endeavors to market and launch missions and other charitable programs that benefits those member churches.

Vyzyn, Inc. is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purposes. Any such assets not

disposed of shall be disposed or by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
