NonProfit Articles of Incorporation For SB Sugar Britches I, Inc.

The undersigned, incorporator, for the purpose of forming a nonprofit corporation under the Florida Business Corporation Act, Chapter of the Florida Statutes hereby adopts the following Articles of Incorporation.

Article I. Name of Corporation

The name of the non-profit corporation is SB Sugar Britches I, Inc. to as the "Corporation"

Article II. Principal Office and Mailing Address

The address of the principal office is 4050 SW 69th Way, Miramar, Florida 33023.

Articles III. Purpose of the Corporation

The primary purpose of this organization is exclusively for charitable, religious, education and scientific purposes including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

This is a non-profit charitable organization formed for the purpose of establishing and operating residential facilities, group sessions, and community based programs geared towards empowering our youth and the family.

We will perform in compliance with Chapter 616, Florida Statutes. The corporation shall not carry on any activities not permitted or carries on by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code. Article IV. Dissolution of Corporation

Upon Dissolution of this corporation it's assets remaining after payment or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501c3 of the Internal Revenue Code or shall be distributed to the federal government or state or local government for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying propaganda or otherwise attempting to influence legislation (except as otherwise provided by section 501 (h) of the Internal Revenue Code, and this corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of or be distributable to it's members, directors, officers, or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles this corporation shall not carry on any activities not permitted to various on (1) by a corporato9n exempt from federal income tax under section 501c3 of the Internal Revenue Code or (2) by a corporation contributions to which have deductible under section 170c2 of the Internal Revenue Code

Article V: Manner of Election

The number of directors of this organization shall be set by the By-Laws, but in no event shall be less than (3) directors. The Number of Directors of this organization shall elect by majority vote the directors to fill vacant and/ or additional positions. The Initial Board of Directors shall be appointed by Natasha Venise Renee Kelly.

Article VI: Amendment

These Articles of Incorporation may be amended at any regular meeting or special meeting of the Board of Directors by a majority vote of those present; provided that notice of intention to submit amendments shall have been given as provided by the bylaws.
