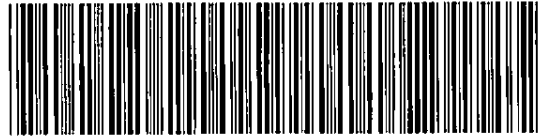

Amend Article III . Impact Justice & Equity Solutions Inc. is a non-profit corporation and shall operate exclusively for charitable, religious, educational, and scientific including, for such purposes, the making of distributions to organizations that may qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

Impact Justice & Equity Solutions, Inc. is organized exclusively for charitable purposes under 501c3 of the Internal Revenue Code. We strive to promote self-sufficiency amongst socially and economically disadvantaged individuals with a special emphasis on those impacted by the justice system . We achieve this through workforce development preparation services, education and occupational skills training.

Add Article IX. Dissolution

Upon the dissolution of this organization, assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.


