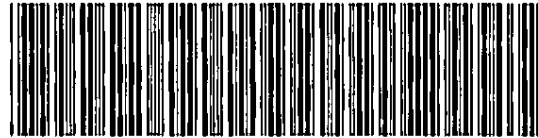



Pursuant to the provisions of §617.1006, *Fla. Stat.*, GOLF VIEW TERRACE CONDOMINIUM ASSOCIATION INC ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

**FIRST: Amendment adopted:**
