Attachment to Articles of Incorporation of Empower Florida, Inc.

Empower Florida, Inc is organized and operated exclusively for the promotion of social welfare within the meaning of 501(c)(4) of the Internal Revenue Code of 1986 (as amended) or the corresponding provision of any future United States internal revenue law, including for such purposes, the making of distributions to organizations which are recognized as exempt from tax under such 501(c)(4), including but not limited to: (1) developing and advocating for the adoption or rejection of legislation, regulations, and government programs for the Developmental Disabilities Waiver Providers and Assisted Living Facility owners (2) by promoting the legal rights of the Developmental Disabilities Waiver Providers and Assisted Living Facility owners and (3) rehabilitation and job placement of members.

The Corporation may devote a substantial part of its activities for lobbying purposes (including the publishing or distribution of statements) or otherwise attempting to influence legislation. However, the Corporation may participate or intervene in (including the publishing or distribution of statements) any political or judicial campaign on behalf of any candidate for public office only to an insubstantial degree.

No part of the net income or net assets of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers, members or other private persons. However, the Corporation is authorized to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of its tax-exempt purposes.

Upon the dissolution or winding up of the Corporation, all of the business, properties, assets and income of the Corporation remaining after payment, or provision for payment, of all debts and liabilities of this Corporation, shall be distributed to a nonprofit fund, association, or corporation which is organized and operated exclusively for tax exempt purposes which are reasonably related to the purposes and goals of this Corporation, as may be determined by the Board of Directors of this Corporation in its sole discretion, and which has established its tax exempt status under 501(c)(3) or 501(c)(4) of the Internal Revenue Code of 1986, as amended.
