**ARTICLES OF INCORPORATION
OF

This organization is formed primarily for social and recreational purposes. Notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1956, or the corresponding provisions of any future United States Internal Revenue Law.

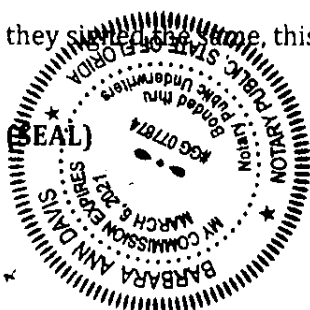
