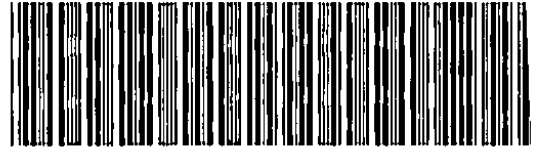

Pursuant to the provisions of section 617.1006, Florida Statutes, this **Florida Not For Profit Corporat** adopts the following amendments to its Articles of Incorporation:

- A. The following new amendment totally replaces **Article III** (The Purpose Statement) to now read follows:

The Corporation is organized exclusively for charitable, religious, educational, scientific, literary, fostering national or international amateur sports competition and preventing cruelty to children animals as defined in Section 501(c)(3) and other related sections of the Internal Revenue Code corresponding sections of any future federal tax code.

- B. The following new **Article IX**: Duration and Dissolution of the Corporation's:

The Corporation shall exist perpetually until dissolution. Upon dissolution, the Corporation's assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose.

- C. The following new **Article X**: Restriction on the Corporation's Operations and Activities:

At all times during its existence, the following shall be conditions restricting the Corporation's operations and activities:

1. No part of the net earnings of the Corporation shall inure to the benefit of, or be in anywise distributed to its members, trustees, officers, directors, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purpose set forth in the purpose statement of these Articles.
2. No substantial part of the activities of the Corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or intervene in, including by publication or distribution of statements, any political campaign on behalf of, or in opposition to, any candidate for public office.
3. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a nonprofit corporation or organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or corresponding sections of any future federal tax code.
