To the Secretary of State:

The undersigned acting as incorporator of a not-for-profit Florida corporation in compliance with Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

NAME

The name of the corporation shall be Run for Purpose, Inc.

ARTICLE II

PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS

The principle place of business and the mailing address of this corporation is to be located at:

436 Dunaway Dr. Valrico, Florida 33594

in the City of Valrico, County of Hillsborough, State of Florida, and may transact its business and maintain offices for such purposes at such other places either within or without this State.

ARTICLE III

PURPOSE

Said corporation is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations under Section 501c(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code.)

The corporation will operate a non-profit Public Foundation in Hillsborough County.

ARTICLE IV

MANNER OF APPOINTMENT OF OFFICERS AND TRUSTEES

The manner in which the Trustees are appointed by the President is as follows:

The Board of Directors/Trustees of the Organization shall be composed of at least three (2) appointed officers and no more than nine (9) trustees in total.

The appointed officers of the Organization shall be the Vice President and Treasurer.

The appointed officers, trustees will hold office until removed. The Board of Trustees will establish the term of office at the time of appointment.

New offices may be created and filled at any meeting of the Board of Directors/Trustees.

A vacancy in any office because of death, resignation, removal, disqualification, or otherwise, may be filled by appointment by the President.

ARTICLE VI

LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, Trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding an other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE VII

DISSOLUTION

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.
