# ARTICLES OF INCORPORATION OF

### LOW RIDER DACHSHUND RESCUE OF FLORIDA, INC.

A Florida Not-For-Profit Corporation

The undersigned person, acting as incorporator of a corporation not-for-profit under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation for such corporation:

### ARTICLE I

The name of this corporation is LOW RIDER DACHSHUND RESCUE OF FLORIDA, INC., a Florida not-for-profit corporation.

### ARTICLE II

The address of the principal office of the corporation and its mailing address is:

ARTICLE III
DURATION

This corporation shall have perpetual duration.

### ARTICLE IV PURPOSES

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, of the corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inture to the benefit of, or be distributable to its members, trusters, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the

corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE V POWERS

This corporation shall have the power to do everything necessary, proper, or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Incorporation, including, but not limited to, power to perform contracts for any lawful purpose, to engage in various funding and fund raising activities, and to acquire, hold, operate, maintain, and lease real and personal property to effectuate its purposes.

### ARTICLE VI MEMBERS

This corporation shall have no members.

## ARTICLE VIII DIRECTORS

## ARTICLE XI DISSOLUTION

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

### ARTICLE XII AMENDMENT

These Articles of Incorporation may be amended by a two-thirds (2/3) vote of the Directors. The undersigned, being the incorporator of this corporation, for the purpose of forming this not-for-profit corporation under the laws of Florida, have executed these Articles of Incorporation of LOW
