Last year I took over as president of our condominium association. We are a small association with only four condominium units. I registered our condominium association with the state without knowing that already were registered as Beach Parkway Associates Inc. So, we currently have two registrations. I filed our annual report this year under La Buena Vida Condo Association Corp. We are currently making amendments to our bylaws, and when I spoke to our attorney, she told me that the new registration (La Buena Vida...) is not legal or not correct. We can't amend the bylaws until we have this straightened out.

After speaking with her and also your department, she suggested that we merge the two existing names and create the correct name which is "La Buena Vida Condominium Association Inc.". This will allow the history of filings with the state under both names to be carried forward under the new name. The new name was used in the past by someone, however, it was involuntarily dissolved in 1980. I was told by your department that we can use the name as long as it is not currently being used by someone else.
