Article III of the Articles of Incorporation is hereby deleted in its entirety and the following substituted in lieu thereof:
The Corporation is organized exclusively for charitable, religious, scientific, educational or literary purposes, including, for
such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of
the Internal Revenue Code of 1986, as amended (or the correspondence provision of any future United States Internal
Revenue law. The Corporation is organized for purposes of engaging in any activity or business permitted under the laws of
the United States and of the State of Florida and shall have all of the powers enumerated in the Florida Not for Profit
Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable
law; provided, however, that the Corporation shall not engage in any activity in which corporations qualified as exempt
organizations under Section 501(c)(3) of the Code are not permitted to engage. No part of the net earnings of the Corporation
shall inure to the benefit of, or be distributable to, the Corporation's directors, officers, or other private persons, except that the
Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments
and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the Corporation
shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not
participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of,
or in opposition to, any candidate for public office. Notwithstanding any other provision these Articles, the Corporation
shall not carry on any other activities not permitted to be carried on by (i) a corporation exempt from federal income tax
under Section 501(c)(3) of the Code, or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2)
of the Code.
