



UPG MISSIONS, INC., a Florida corporation not-for-profit, hereby presents these Articles of Dissolution evidencing the dissolution and discontinuation of business of UPG Missions, Inc., and sets forth the following pursuant to the provisions of Section 617.1403, *Florida Statutes*:

1. The name of the corporation not-for-profit is UPG MISSIONS, INC. (the "Corporation").
2. The Articles of Incorporation of the Corporation were filed on April 20, 2017 and assigned document number N17000004323.
3. The Corporation has no members.
4. The dissolution was unanimously approved by the Board of Directors of the Corporation on April 1, 2019.
5. The effective date of the dissolution of the Corporation shall be the date these Articles of Dissolution are filed with the Department of State of the State of Florida.
6. All debts, obligations and liabilities of the Corporation have been paid or discharged.
7. All remaining property and assets have been distributed in accordance with the plan of distribution of assets adopted unanimously by the Board of Directors of the Corporation on April 1, 2019 in compliance with Section 617.1406(2), *Florida Statutes*, and in accordance with Section 501(c)(3) of the Internal Revenue Code.
8. There are no suits pending against the Corporation in any court.


**NOTICE OF DISSOLUTION
