**ARTICLES OF INCORPORATION
OF
Lightweavers International, Inc.
A Non-Profit Corporation**

**ARTICLE I
NAME**

The name of this corporation is Lightweavers International, Inc., hereafter "Corporation".

**ARTICLE II
PRINCIPAL OFFICE**

**ARTICLE III
PURPOSE**

The purpose for which this Corporation is organized is to engage in any such lawful act and/or activity under the General Law of Florida other than the banking business, trust company business or the practice of a profession not permitted to be incorporated by and pursuant to the Florida Corporations Statute.

The specific purpose is establish a spiritual ministry dedicated to understanding and developing the people's highest potential, the Light Within each, through religious, educational and charitable activities and services to include:

- (1) Regular weekly spiritual services;
- (2) Community service;
- (3) Lightweaving classes and workshops;
- (4) Spiritual healing and counseling; and
- (5) Other activities consistent with these Articles of Incorporation, and Section 501(c) (3) of the Internal Revenue Code, as may be approved from time to time by the Directors.

**ARTICLE IV
MANNER OF ELECTION**

The directors shall serve for a period of two (2) years. During the last regularly scheduled meeting of the initial board's term, candidates for director positions shall be nominated and appointed by majority vote of the board of the directors. This nonalienation shall be based on the candidtates' abilities to contribute specific expertise in areas relevant to the corporation's ongoing religious, educational, and charitable services and goals.
