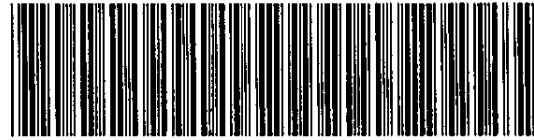

The objective's and purposes for which this corporation, Church and Outreach Ministry is constituting this Corporation is based and Organized on The Florida State Chapter of 617.0301 for To:

- I. To dedicate infants, To Unionized couples in matrimonies, To commence the Dead to bury and to Anoint the sick with Bless Oil and all functions In the Name Of The Lord.
- J. To act with charitable concerns for all in need of help rather in or out of the ministry regardless of race creed or sex, social position, religious affiliations; for the action for carrying out the actions for the poor, both within or out of the church corporation.
- K. To pray for the needs of all people and for local, national, world leaders, government and institutions.
- L. ## **ARTICLES IV: POWERS**

This term for which this corporation shall exist and be perpetual.

To the end of the afore going objectives and, this Schools and Churches Corporation purposes and any religious and charitable purposes may be carried out, performed and accomplished shall have the power charitable, literary, Musical and educational purposes. It shall engage only in such activities as are permitted to be contributions to which are deductible pursuant to Section 170(c)(2), of the Internal Revenue Code of 1954 or corresponding provisions of any future United States Internal Revenue Code. Any provision elsewhere in these Articles of incorporation to the contrary notwithstanding, this corporation shall not engage in nor attempting to influence legislation, or participating in or intervening in any political campaign on behalf of the private or public office nor any propaganda, nor shall any net earnings or assets inure to benefit any private member. Subject to the afore going limitations, and subject specifically to the provisions of Sections 611.0105 of the Florida Statutes, this church Corporation shall have all of the rights and powers set forth in Section 607.0128, 617.021 and Section 617.0302 of the Florida Statutes. The purposes set forth in Article III her of shall likewise be construed as powers. Such powers shall specially include, but not be limited to, the following:

- To raise funding for the sake of the ministry of KINGDOM BUILDERS CHANGE OF HEART OUTREACH MINISTRY INCORPORATED an any and all forms of schools.
- To acquire, own, or lease mortgages and disposed of properties both real and personal
- To carry and Conduct instructional or religious services through media and printed material
- To acquire, own and operate such printing, software and/or internet providers, broadcasting, telecasting and television.
- To accept property and donations in trust for religious or charitable purposes.
- To acquire, hold, own sell assign, transfer, mortgage, pledge or otherwise dispose of any properties for the purpose of the corporation and while the owner therefore exercise all rights, powers and privileges of ownership, including the power to vote thereon.
- To establish and maintain operational control and no board members shall influence in any matter without a vote within Florida Statutes said; 20 members or less and two thirds of a quorum.
- To write books, Musical collections and Host Christian events or any and all projects for the building of the ministry.
- To establish schools, daycares, summer camps, afterschool programs, vacation bible school, conduction adult trainings and seminars.
- To Ordain Minister upon Completion of the prescribed course of study, designated by the corporation; to assist in in the establishment of Ministers, Deacons, Evangelist, Ushers and the maintenance of other churches and outreaches.
- To send forth missionaries from within our ministry to established and building of other churches and outreaches both domestic and Foreign.

## **ARTICLES V: MEMBERSHIP**

- They Must keep His Commandments and Publicly confess their faith: they must commit themselves to participate actively and work hard in the ministry.
