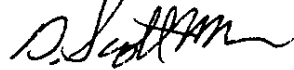

**ARTICLES OF INCORPORATION**

**of**

The undersigned subscriber to these Articles of Incorporation, hereby agrees to form a corporation pursuant to the provisions of Florida Statute 607.

**ARTICLE I**

The name of the corporation shall be: ST MARY MISSIONARY BAPTIST CHURCH, INC., a not for profit corporation, and may hereafter in these Articles of Incorporation may be referred to as the CORPORATION. This Corporation shall be a social purpose corporation pursuant to FS §607.506.

**ARTICLE II**

The Corporation shall have perpetual existence from the date that the Certificate of Incorporation for these Articles of Incorporation is issued by the Office of the Secretary of State of the State of Florida.

**ARTICLE III**

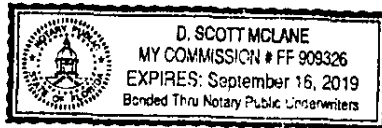

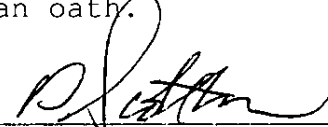
