## ARTICLES OF INCORPORATION OF PIERRE FAUCHARD ACADEMY FLORIDA SECTION, INC.

In compliance with the requirements of the Florida Not For Profit Corporation Act, the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

## ARTICLE I NAME

The name of the corporation shall be "Pierre Fauchard Academy Florida Section Inc. (the "Corporation").

## ARTICLE II INITIAL PRINCIPAL OFFICE

The street and mailing address of the initial principal office of the Corporation is 374 SW Prima Vista Blvd, Port St Lucie, FL 34983.

## ARTICLE III PURPOSE

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## ARTICLE IV MANNER OF ELECTION

The method of election of directors of the Corporation shall be stated in the bylaws of the Corporation.

### ARTICLE V INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 374 SW Prima Vista Blvd, Port St Lucie, FL 34983. The name of the initial registered agent of the Corporation at that office is Reza Ardalan.

### ARTICLE VII MISCELLANEOUS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
