The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

#### **ARTICLE 1 - NAME**

The name of the Corporation is WE ARE BREAKING BARRIERS, INC., (hereinafter "Corporation).

#### **ARTICLE 2 - PURPOSE OF CORPORATION**
