Notwithstanding, any other provisions of these articles, **ENTER GRACE MINISTRIES**, **INC.** shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

All titles, copyrights, royalties or similar interest in electronic recordings, books, online publications or any other materials prepared for ENTER GRACE MINISTRIES, INC. activities will be held by ENTER GRACE MINISTRIES, INC. and it's name.

Articles of Incorporation: Dissolution of Assets Provision

The distribution of assets upon dissolution of final liquidation shall be as follows:

ENTER GRACE MINISTRIES, INC. shall be perpetual, upon dissolution of ENTER GRACE MINISTRIES, INC. assets shall be distributed to one or more designated exempt, not for profit organization(s) within meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of county in which the principle office of the organization is then located, exclusively for such purposes.
