AMENDMENT ARTICAL 3 STATE FILING

The general purposes for which Outdoor Valor, Inc. has been established are as follows:

Outdoor Valor, Inc. is established within the meaning of IRS Publication 557 Section 501 (c)(3) of the Internal Revenue Code as amended from time-to-time (the "Code") or the corresponding section of any future federal tax code. Outdoor Valor, Inc. shall be operated exclusively to take disabled, Purple Heart veterans and Gold Star family members, as well as active duty members with PTSD offshore fishing at no charge. We provide a complete charter service that includes all tackle, bait, ice, and license for the participants. We also provide reimbursement for travel fees and food expenses for those traveling from outside our area. It is our mission to relieve combat stress with fishing. While on these trips with veterans from different branches and years of services, the brotherhood these vets need and a lifetime of bonds that won't be broken are established. On our trips, we provide PTSD life coaching. We are 100% non-profit with no paid employees. None of the gross or net donations will benefit the board members or employees. Everyone is a volunteer, all money raised is to benefit the veterans and the mission.

Outdoor Valor, Inc. shall hold and may exercise all such powers as may be conferred upon any non-profit organization by the laws of the State of Florida and as may be necessary or expedient for the administration of the affairs and attainment of the purposes of the Outdoor Valor, Inc. At no time and in no event shall Outdoor Valor, Inc. participate in any activities which have not been permitted to be carried out by Outdoor Valor, Inc. exempt under Section 501 (c) of the Internal Revenue Code of 1986 (the "Code").

At no time will the activities of this corporation will be to influence legislation, and this corporation shall not participate in, or intervene (including the the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate to any public or private office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or the corresponding section of the future federal tax code.
