



**Articles of Incorporation
Oak Ridge Baptist Church, Inc.**

Pursuant to F. S. Chapter 617, articles on incorporation were filed with the Department of State. These articles were not accepted due to the lack of at least one incorporator with a complete business street address and a signature. In the interim, Dr. (Pastor) Michael D. Castle died. The surviving initial directors shown in the first articles met and arrived at some modifications, which are now commemorated in this replacement instrument.

1. Effective Date. These articles are effective when accepted by the Florida Department of State.

2. Name. Oak Ridge Baptist Church, Inc., a Florida nonprofit corporation.

3. Principal Office. 9714 Ridge Boulevard, Jacksonville, Florida 32208.

4. Mailing Address. The same as the principal office.

5. Purpose. The church is already an active Christian congregation and has been so for some years. The purpose of the church is to provide traditional Christian worship and ministry. The purpose of this corporation is to provide a legal and business entity for the conduction of the business life of the church, including ownership of church property. Therefore, this corporation's purpose is to organize, maintain, operate, and conduct one or more churches and to do anything lawful which might be done by any non-profit corporation.

6. Religious Affairs. The members of the church are now in the process of locating a fulltime pastor. During the life of this corporation, the religious affairs of the church will be under the direction of the fulltime pastor. It is the purpose of this corporate entity to conduct the secular or business affairs of the church. In the event of a conflict between the religious and secular affairs of the church, the religious affairs will prevail.

7. Bylaws. The initial board of directors will adopt bylaws for the governance of this corporate entity. These bylaws may be amended from time to time by the process contained in them, or, if not answered by those bylaws, by the provisions of Chapter 617. These bylaws will provide the express and implied authority for the directors and officers.

8. Initial Directors and Officers.
