ARTICLE I NAME

The name of the Corporation shall be: Kerigma International Ministries Inc.

<u>ARTICLE II PRINCIPAL OFFICE</u>

ARTICLE III PURPOSE

The purpose for which the corporation is organized: Religious Corporation. We are an interdenominational Christian group with an international outreach.
