SONS OF HAITI SUPREME COUNCIL CHARTER, USA. LOCATED AT
301-3RD ST., RENTON, WA 98057

That we, the undersigned, George Waters, associated ourselves together for
the purpose of forming a non-profit corporation under the general laws of
the state of Florida.

AND WE DO HEREBY CERTIFY:

First: The name of the corporation shall be the Most Worshipful Sons
of Haiti Grand Lodge, Ancient, Free and Accepted Masons, Inc.

Second; That the objects and purposes for which this corporation is
formed and the following;

To maintain a grand lodge, auxiliaries, and such lesser organizations
as may be necessary for adequate instruction in the craft of masonry, in
accordance with the doctrines and principles of free masonry.

To establish and maintain such departments and institutions as may be
necessary for the propagation of free masonry and the works of the
institution, ancient free and accepted Masons.

To give and receive contributions for charitable and benevolent purposes: to
publish and circulate books and papers for the dissemination of free
masonry: to engage in Masonic work among all people. With regard to all
races and nationalities and religions.

To hold, manage, administer money, funds, property of such corporation and for the administration and management of its business and affairs, and to purchase, acquire, and to hold real estate, and to construct, maintain and furnish buildings and to make improvements and to receive, purchase, hold, lease, and sell property. To borrow money, give promissory notes or bonds therefore and to secure the payment thereof by mortgage or deed of trust upon the property, real or personal, of the corporation, and to perform all other acts within or without the State of Florida as may be permitted by the General Laws of the State of Florida and the Constitution and laws of the United States of America, and to receive bequests and devises by will, for its own use or upon trust, to the end of effecting the mutual betterment of its members and the community.

To confer degrees of masonry to carry out the purposes and doctrines of the organization.

Third: To principal place of transacting the business of the corporation shall be the City of Malone, Florida.

Fourth: The time of commencement of the existence of the corporation shall be the date of the filing of its articles in the office of the Auditor, Tallahassee, Florida and the duration of its existence shall be one hundred years from that date.

Fifth: Any male person who, by instruction and training, shall have mastered the discipline, doctrine and principles of the Masonic order shall be admitted to membership upon payment of the fees fixed by the by-laws of the corporation.

Sixth: The highest amount of indebtedness or liability to which this corporation shall be at any time subject shall be any time subject shall be One Thousand (\$1,000.00) Dollars, without a vote from the Grand Lodge Members.

Seventh: The affairs of the corporation shall be managed by a board of six directors; that all of such directors are to be elected at the annual meeting of the membership to be held on the second Monday of August of each year at the hour of 8:30p.m. at the principle office of the corporation; that the name and addresses of the persons who are appointed to act as the first directors are as follows:
