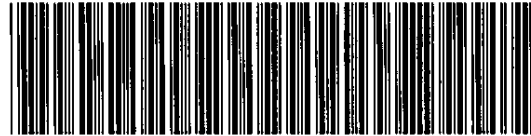

**Articles of Incorporation  
Of  
Go Love Outreach Center, Inc.**

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not for Profit Corporation* adopting the following Articles of Incorporation:

**ARTICLE I: Name of the Corporation**

The name of the corporation is **Go Love Outreach Center, Inc.**

**ARTICLE II: Principal place of business and mailing address**

- A. The principal office address is 607 Avalon Road, Winter Garden, Florida 34787.
- B. The mailing address is P.O. Box 784329, Winter Garden, Florida 34778.

**ARTICLE III: Purpose**

Go Love Outreach Center, Inc. is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**A. MISSION STATEMENT:**

To be a catalyst to serve people living in and around Winter Garden's Tildenville community by helping to meet their social, economic and spiritual needs resulting in real community transformation.

**B. GUIDING PRINCIPLES:**

1. **Presence:** We must BE the community, not just "reach out" to the community.
2. **Leadership Development:** We must develop local community leaders to support the community in the future.
3. **Listening to the Community:** We must listen to the people in this community to understand their real needs, not just assume we know.
4. **Holistic Approach:** We must leverage the impact of multiple Go Love programs and other community partners to best meet the spiritual, social and material needs across the community.
5. **Empowerment:** We must focus on developing self-reliant individuals and families in this community, who are empowered to succeed on their own.

#### **ARTICLE IV: Election of Board of Trustees:**

The Executive Director together with the Board of Directors shall have the right to nominate individuals whom they deem qualified to serve as a Board Member. A candidate for Board shall be elected by the affirmative vote of all remaining Board Members.

The governance of this non-profit organization shall constitute the Board of Trustees of this corporation, and as such, shall have all the powers over the temporalities of this organization as prescribed by civil law and the by-laws of Go Love Outreach Center, Inc.

#### **ARTICLE VIII: Effective Date**

These articles will become effective immediately upon the date of filing.

#### **ARTICLE IX: Membership**

Members may be admitted to this corporation by proper application to the organization. The organization shall judge the applicant's fitness for membership on the basis of the Word of God and such rules as may be adopted by the Board of Trustee of Go Love Outreach Center, Inc. Members will be nonvoting.

#### **ARTICLE X: Terms of Existence**

This corporation is to exist perpetually.

#### **ARTICLE XI: By-Laws**

The by-laws of this corporation shall be those which apply to Go Love Outreach Center, Inc. In addition, the Board of Trustee may, be a majority vote of those present, make such local regulations as it sees fit, and by a 2/3 majority vote of those present amend or

rescind such local regulations. At any meeting of the Board where by-laws are made, amended or rescinded, a majority of the Board must be present.

#### **ARTICLE XII: Amendments**

Amendments to these Articles of Incorporation may be adopted by the Board by a two-thirds majority; provided however that no amendment may be adopted which conflicts with the by-laws of Go Love Outreach Center, Inc. A majority of the Board must be present at any meeting passing on such amendments.

#### **ARTICLE XIII: Address**

The post office address of the principal office of this corporation in the State of Florida is 607 Avalon Road, Winter Garden, Florida 34787.

#### **ARTICLE XIV: Dissolution**

Upon termination or dissolution of Go Love Outreach Center, Inc., any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(3)(c) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the termination or dissolving corporation.


The organization to receive the assets of Go Love Outreach Center, Inc. hereunder shall be selected by the discretion of a majority of the Board of Go Love Outreach Center, Inc. and if its Board cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against Go Love Outreach Center, Inc. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose which at least general includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

#### **ARTICLE XV: Property and Debt**

Debts or liability of this corporation, payable to persons or agencies other than Go Love Outreach Center, Inc., shall never exceed two-thirds the value of the property of the corporation.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity


