### ARTICLES OF INCORPORATION OF

## PHOEBE LOUISE DOOLEY FOUNDATION, INC. In Compliance with Chapter 617, Florida Statutes (Not for Profit)

#### **ARTICLE I: Name**

The name of this Corporation shall be PHOEBE LOUISE DOOLEY FOUNDATION, INC., a Florida Not for Profit Corporation.

#### **ARTICLE II: Principal Office**

The principal place of business and mailing address of this Corporation shall be

#### ARTICLE III: Purpose

- a) Notwithstanding any other provision of these Articles, the purposes for which this Corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- b) Notwithstanding any other provisions of these articles, this Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- c) Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
- d) In accordance with the above requirements, the specific purposes for which this Corporation is organized are: to increase awareness of Diffuse Intrinsic Pontine Glioma and other childhood cancers; to provide support and resources to the families of hospitalized children; and to raise funds to support childhood cancer research.
