Article III is being amended to read: This corporation is founded exclusively for charitable purposes within the
meaning of the IRS Code Sec 501(c)(3); namely: To provide support and relief to disadvantaged or disabled persons with
artistic talents located in south Florida and elsewhere by assisting them in A) purchasing the supplies they need to practice
their arts; B) by providing training in the arts or in other skills related to success and happiness; C) by providing counseling
to enhance coping, family and interpersonal skills; D) by providing platforms, venues and other channels whereby these
artists may offer their works for sale to collectors and the general public; E) by carrying out any and all activities deemed
by the directors to be conducive to helping these artists gain self sufficiency and confidence, integration into the
main stream, and entry into the highly competitive field of the art world. This organization will strive to bring these artists
to the attention of the community, in an individualized way, so they may fulfill their dreams and aspirations.
This corporation shall be empowered to receive and sell artistic works, the proceeds of which will be dedicated to the
furtherance of its charitable goals.
Upon the dissolution of this organization, after clearing all debts, its remaining assets shall be distributed to one or more
organizations with similar exempt purposes recognized under section 501(c) (3) of the Internal Revenue Code.
This corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not
in furtherance of the charitable purposes of this corporation. It will not distribute dividends to any of its directors or officers.
It will not attempt to influence legislation in any way or participate in political campaigns of any sort.
