# ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F. S., (Not for Profit)

## **Article I: Name**

The name of the corporation shall be: Community Action for People Empowerment, Inc.

## **Article II: Principal Office**

The principal place of business and mailing address of this corporation shall be: 1211 Old Hwy 17, Crescent City, Florida 32112

## **Article III: Purpose**

The purpose for which the corporation is organized is: To address with aims of fulfilling the needs of all people, with particular emphasis on ex-felons, in developing and maintaining a wholesome life within accepted social, intellectual and cultural paradigms via education, counseling, community organization and orientation into the political, economic, cultural and social life of the community.

## **Article IV: Manner of Appointment**

The manner in which the directors are appointed: The original board members are the founding members of the organization and subsequent board members shall be appointed by a unanimous vote of active board members. There shall always be an odd number of board members, no less than three and no more than nine. An active board member is one who meets quarterly/year unless absence is excused by the members present.

## **Article V: Dissolving of Corporation**

If this corporation shall ever be dissolved the assets and physical properties owned by the corporation shall be donated to an existing non-profit organization with like or similar purpose and service by a majority of vote by the board of directors.

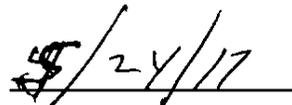

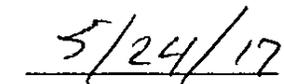
