Pursuant to the provisions of Chapters 617 and 607, Florida Statutes, RITEWAY BLS SERVICES, INC. adopts the following Amended & Restated Articles of Incorporation, effective on April 1, 2022.

These Amended & Restated of Articles of Incorporation of RITEWAY BLS SERVICES, INC., a Florida corporation duly registered in the State of Florida, originally on the 1st day of June, 2017, there being no members with the right to vote, were unanimously approved by the Corporation's Board of Directors, therefore, the number of votes cast for the amendments by the Board of Directors was sufficient for approval.

These Amended and Restated Articles of Incorporation of RITEWAY BLS SERVICES, INC. consolidate all of the amendments into this single document.

The date of adoption of each amendment contained herein is April 1, 2022.

**ARTICLE I
Corporate Name**

The name of this Corporation is **RITEWAY BLS SERVICES, INC.** (hereinafter referred to as the "Corporation").

**ARTICLE II

**ARTICLE III
