Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: It will be a youth center, This will be a safe haven for teens. Cafe /coffee shop and consignment to fund the youth center. With a computer center and video games and hockey table. A huge part of it would be music and they are building a mini stage to pull the talents from the teens.
