**ARTICLES OF INCORPORATION
OF
790 CONDOMINIUM ASSOCIATION, INC.**

In compliance with the requirements of Chapter 617, Florida Statutes, the undersigned, all of whom are residents of the State of Florida, and all of whom are of full age, have this day voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

**ARTICLE I
NAME**

The name of the corporation is **790 CONDOMINIUM ASSOCIATION, INC.** For convenience, the corporation shall be referred as the "association", these articles of incorporation as the "articles", and the bylaws of the association as the "bylaws" hereafter called the "Association".

**ARTICLE II
ADDRESS**

The principal office of the Association is located at: 801 NW 37 Ave., Ste 206, Miami, Florida 33125.

**ARTICLE III
REGISTERED AGENT**

Lazaro J. Lopez, whose address is 2333 Brickell Avenue, Ste. A-1, Miami, Florida 33129, is hereby appointed the initial registered agent of this Association.

**ARTICLE IV
PURPOSES AND POWERS OF THE ASSOCIATION**

This Association does not contemplate pecuniary gain of profit to the members thereof, and the specific purposes for which it is formed are provide an entity under the Florida Condominium Act ("The Act") for the operation of a condominium located in Miami-Dade County, Florida, and known as 790 Condominium Association Condominium, Inc., a condominium ("the condominium") to be created under the declaration of condominium ("the declaration"); maintenance and preservation of the common areas, entrance, promote the health, safety and welfare of the residents within the property and any additions thereto as may hereafter be brought within the jurisdiction of this Association; exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in that certain Declaration of Condominium recorded in the Public Records of Miami-Dade County, Florida.



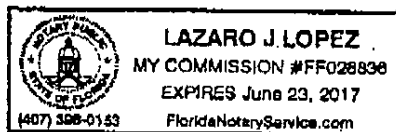


