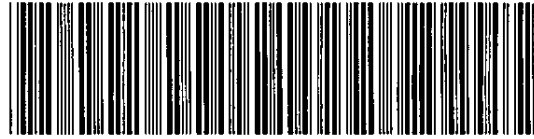

Articles of Incorporation

Article I Corporate Name

The name of the corporation shall be:

KRISHNAITES UNITED INC.

Article II Principal Office

The corporation's principal place of business and mailing address shall be

Article III Organization and Purpose

The corporation is organized exclusively for charitable, cultural, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Specifically

To establish and maintain an independent mission to popularize the teachings of His Divine Grace A.C. Bhaktivedanta Prabhupada, authorized by the disciplic succession from Lord Chaitanya Mahaprabhu, who rejected the system of cultural distinction based on bodily caste, color and creed in 16th Century India as contrary to the cause of universal spiritual equality and happiness and who inaugurated the bona fide reformation known then and now as the Hare Krishna Movement.

To carry out this mission by all means possible, but with special emphasis on the following:

- The public distribution of the authentic, uninterpolated, spiritual wisdom of the Vedic literature of India as translated by Srila Prabhupada with elaborate commentaries, strictly according to the Gaudiya Vaishnava disciplic succession from Lord Chaitanya, and transcribed or published prior to November 14, 1977, the time of Srila Prabhupada's disappearance.
- The education and spiritual upliftment of persons eager to advance their knowledge and practice in the science of bhakti yoga (devotional service) as presented by Srila Prabhupada in his literatures and recordings.

To do all other things necessary and proper in furtherance of the above stated purposes.

Article VII Corporate Existence

The duration of the corporation shall be perpetual.

Article VIII Limitations on Corporate Powers

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes set forth in these Articles of Incorporation.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX Dedication and Distribution of Assets

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

In the first instance, such assets shall be distributed to *The Hari Nama Mission (Mission of The Divine Name)*, a California Domestic Nonprofit Corporation, Calif. Reg. C1868301.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


