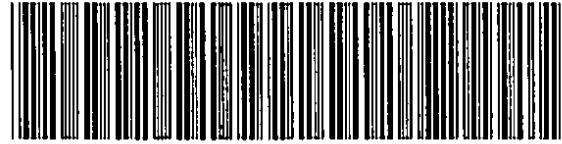

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
NEWCO HEALTH FIRST COMMERCIAL PLANS, INC.**

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation as currently filed with the Florida Department of State is NEWCO HEALTH FIRST COMMERCIAL PLANS, INC. (the "Corporation").
2. The Document Number of the Corporation is N17000006151.
3. The Articles of Incorporation of the Corporation are hereby amended as follows:

Article I is hereby deleted in its entirety and replaced with the following:

ARTICLE I – NAME

The name of the corporation shall be **HEALTH FIRST COMMERCIAL PLANS, INC.** (the "Corporation").


