

Articles of Incorporation of Journey Church of Hamilton County, Inc.

In Compliance with Chapter 617, Florida Statutes (Not for Profit)

Article One - Name

The name of the Corporation shall be Journey Church of Hamilton County, Inc.

Article Two - Principal Office

The principal place of business and mailing address of the Corporation shall be:

Article Three - Purpose

The corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article Four - Manner of Election

The Directors of the corporation, and any other such officers as shall be created by the bylaws of the corporation, shall be elected at the annual meeting of the corporation and in conformity with the bylaws of the corporation.
