#### Article 5

No substantial part of the activities of the corporation shall be the carrying on of propaganda, otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate in public office.
- Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be on by a corporation exempt from federal income tax under section 501(C) 3 of the Internal Revenue Code.

#### Article 6

#### **COVENANT TO SUE**

The Corporation agrees that it will reserve the right to institute or not to institute any action or suit at law or in equity against any director of the Corporation, or institute, prosecute, or in any way aid in the institution or prosecution of any claim, demand, action, or clause of action for damages, loss or injury to person or property, or both, whether developed or undeveloped, resulting or to result, known or unknown, past, present, or future arising, out of a director or officer of the Corporation's service to the Corporation.
