# ARTICLES OF INCORPORATION

## ARTICLE I NAME

### 1.01

The name of this corporation shall be Juanita M Smalley Center for Wholeness and Wellness, Inc. The business of the corporation may be conducted as The Center for Wholeness and Wellness (CWW).

## ARTICLE II DURATION

### 2.01 Duration

The period of duration is perpetual.

## ARTICLE III PURPOSE

### 3.01 Purpose

Juanita M Smalley Center for Wholeness and Wellness, Inc. is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

Juanita M. Smalley Center for Wholeness and Wellness, Inc. purpose is to educate, coordinate, and facilitate family literacy initiatives designed to build healthy and strong families through illuminating spiritual wholeness and wellness through education and service.

Programmatic initiatives will include literacy training (spiritual and mental health fitness, financial management, nutrition, service learning, leadership development, healthy food distribution, character development, senior health and compassion in action). Leadership development will include training to raise social consciousness about the importance of developing the whole person (physically and spiritually) to better meet the needs of Lake County community members disaffected by malnutrition, illicit drug use, and the many other ills fraying the moral fabric of society.

To maximize our impact, we seek to collaborate with other non-profit organizations which fall under the 501 (c) (3) section of the Internal Revenue code and are operated exclusively for educational and charitable purposes. We will work in partnership with members of the Macedonia Church of the Living God to provide nutritional food through a faith-based food bank for families in need in Leesburg (Lake County), Florida.

Per the discretion of the Board of Directors there will be internships and other volunteer opportunities to provide intergenerational involvement, collaboration with higher education institutions in the region to support said activities and program developments and to ensure broad impact.

### **3.02 Public Benefit**

Juanita M Smalley Center for Wholeness and Wellness, Inc. is designated as a public benefit corporation.

## **ARTICLE IV NON-PROFIT NATURE**

### **4.01 Non-Profit Nature**

Juanita M Smalley Center for Wholeness and Wellness, Inc. is organized exclusively for charitable and educational purposes including for such purposes, the making of distributions to organizations that qualify as exempt organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of Juanita M Smalley Center for Wholeness and Wellness, Inc. shall inure to the benefit of, or be distributable to its directors, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause thereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section any future federal tax code.

Juanita M Smalley Center for Wholeness and Wellness, Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

### **4.02 Personal Liability**

No officer or director of this corporation shall be personally liable for the debts or obligations of Juanita M Smalley Center for Wholeness and Wellness, Inc. of any nature whatsoever, nor shall any of the property or assets of officers or directors be subject to the payment of the debts or obligations of this corporation.

### **4.03 Dissolution**

Upon termination or dissolution of Juanita M Smalley Center for Wholeness and Wellness, Inc., any assets lawfully available for distribution shall be distributed to one (1) or more organizations described in Section 501 (c) (3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which

organizations have charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation in the State of Florida.

#### **4.04 Restricted Activities**

No part of the corporation's activities shall be the carryon of propoganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene, including the publishing or distributing of statements in any political campaign on behalf or in opposition to any candidate for public office.

### **ARTICLE V BOARD OF DIRCTORS**

#### **5.01 Governance**

Juanita M Smalley Center for Wholeness and Wellness, Inc. shall be governed by its Board of Directors.




