Add a new Article IX to the existing Articles of Incorporation which will provide as follows:

ARTICLE IX: Referring to the "Stormwater Management System" (SMS) for SUNRISE Subdivision (according to plat thereof recorded in Plat Book 19, Pages 58 and 58A, of the Public Records of Escambia County, Florida) which was designed and constructed accordance with Permit No. IND-033-17747-1 issued by the Northwest Florida Water Management District (NFWFMD), this Corporation shall, among other things, operate, maintain and manage such SMS in a manner consistent such permit and applicable rules and regulations of the NFWFMD; assist on the enforcement of any restrictions and covenants relating to the SMS; shall levy and collect adequate assessments from members of this Corporation for the maintenance, costs, operations and repair of the SMS, including, but not limited to, work within retention areas and drainage structures and easements; and prior to any termination, dissolution or liquidation of this Corporation, the responsibility for the operation and maintenance of the SMS must be transferred to, and accepted by, an entity which complies with Rule 62-330.310, Florida Administrative Code and the NFWFMD's Applicants Handbook, Volume 1, Section 12.3, and be approved by the NFWFMD prior to such event.


