Amendments Adopted-

Article III

Ralph Williams Elementary PTO is dedicated to nurturing an environment that enriches learning and enhances the school experience for students, teachers and staff. Ralph Williams Elementary PTO is organized and operated exclusively for educational, charitable, and community building purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or to any corresponding provision of any future federal tax law. Ralph Williams Elementary PTO's purpose is as follows

- Supporting educational and extracurricular activities that contribute to the holistic development of students.
 - 2. Encouraging excellence in students, teachers, and staff.
- 3. Providing a platform for effective communication and collaboration among parents, teachers, and school administration.
- 4. Supplement educational programs, resources, recognition of teachers and staff, and other needs that are not otherwise covered by school budgets.
- 5. Encouraging and organizing volunteer efforts to support school events, activities, and needs.

Ralph Williams Elementary School PTO will conduct fundraising activities to provide the necessary resources for the above activities.

Notwithstanding any other provision hereof, the Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code (or the corresponding provision of any future federal tax code), or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code (or the corresponding provision of any future federal tax code).

Article IX

No part of the net earnings of the Corporation shall inure to the benefit of any trustee, director, or officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation), and no trustee, director or officer shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the Corporation. No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting, to influence legislation (except as otherwise provided by Section 501(h) of the Code), or participating in, or

intervening in (including the publication or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

Article X

Upon the termination, dissolution or final liquidation of the Corporation in any manner and for any reason, the Board of Directors shall first pay or provide for the payment of all liabilities of the Corporation; all remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code (or the corresponding section of any future federal tax code), or shall be distributed to the federal government, or to state or local government, for a public purpose.
