Amended Articles of Incorporation Of Faith Global, Inc (A Corporation Not for Profit)



We, the undersigned, natural persons, who are over the age of 18 years or more, acting as incorporators of a corporation under the Florida not for Profit Corporation Act, do herby adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is FAITH GLOBAL INC. The principle office and mailing address of the corporation is 1845 San Marco Road, Marco island, Florida 34145.

ARTICLE II.

The corporation is a nonprofit corporation.

ARTICLE III. DURATION

The period of its duration is perpetual. The commencement of this corporation shall be June 19, 2017.

ARTICLE IV. MEMBERSHIP

The qualifications of membership of this corporation and the manner of admission shall be regulated by the Bylaws.

ARTICLE V.

This corporation shall be organized and operate exclusively for religious purposes within the meaning of Section 501©(3) of the Internal Revenue Code of 1986, as amended, or any superseding section in order to:

- a) Function as a church or an Association of Churches within the meaning of Section 170(b)(1)(A)(1) of the Internal Revenue Code;
- b) Minister the Word of God
- c) Provide places for and conduct public and private religious worship services through various forms of ministry.
- d) Promote and encourage, through the minsitries of the organization, cooperation with other organizations ministering within a community.
- e) Spread the Word of the Gospel through seminars, radio, television, and other forms of mass media for the purpose of educating the individual in the Word of God.

- f) Conduct a local church by the direction of the Lord, Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the provisions as set forth in the Holy Bible.
- g) Establish new churches in affiliation or association with the local church and establish and support an association of churches, missions, and missionaries.
- h) Conduct, establish, and maintain Christian educational institutions.

- i) Ordain, commission, and license minsters of the gospel in accordance with a prescribed course of study.
- j) To do any and all things necessary to accomplish Religious charitable purposes within the meaning of Section 501©(3) of the Internal Revenue Code and the laws of the State of Florida.
- k) To receive and maintain a fund or funds of real or personal property, or both, and, subject to the restrictions and limitations herein set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, literary or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501 of the Internal Revenue Code and its Regulations as they now exist or as they may be amended.
- Notwithstanding any other provision for these Articles of Incorporation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501 of the Internal Revenue Code and its Regulations and the laws of the State of Florida as they now exist or as they may be amended

ARTICLE VI.

No part of the net earnings of the nonprofit corporation shall inure to the benefit of or be distributed to its members, trustees, directors, officers or other private persons with the exception that the corporation is empowered to pay necessary and reasonable compensation and expenses for services rendered and to make payments and distributions in furtherance of the corporations' purposes as set forth in Article V. The corporation shall not engage to a substantial extent in lobbying or influencing legislation. The corporation is organized pursuant to the Florida Not for Profit Corporation At and does not contemplate pecuniary gain or profit and is organized solely for nonprofit purposes.

Upon the dissolution of the corporation and the winding up of its affairs, the assets of the corporation shall, after paying or making provisions for the payment of the liabilities of the corporation, dispose of all the assets of the corporation elusively for the purposes of the corporation to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under provision of Section 501©(3) of the Internal Revenue Code of 1986 as amended, or any superseding section, any assets not so disposed of, shall be disposed of by a court of competent jurisdiction for the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated for such purposes.

ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 1845 San Marco Road, Marco Island, Florida, 34145, and the name of its registered agent is Andre Roebert.

ARTCLE VIII. BOARD OF TRUSTEES
