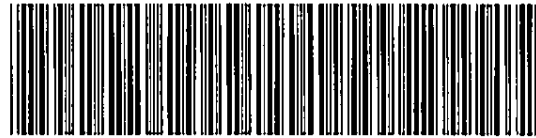

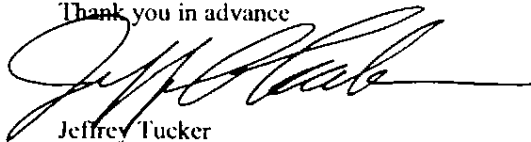
Dear staff,

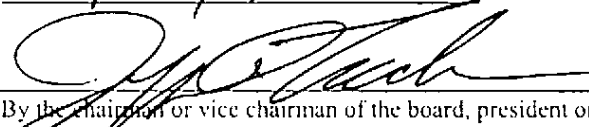
