The organization shall operate exclusively for religious, charitable, educational and other purposes within the meaning of section 501(c)(3) of the United States Internal Revenue Code of 1986 (hereinafter "Code"). Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment of all debts and liabilities shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.
