# ROSEWOOD ECCLESIA

## RESTATED ARTICLES OF INCORPORATION

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:*

### Article I NAME AND ADDRESS

The congregation of believers shall be known as Rosewood Ecclesia also known as and referred to as "Rosewood Center" or "Rosewood Apostolic Center." It is incorporated as a non-profit corporation under the laws of the state of Florida. The address of Rosewood Ecclesia, is 445 S. Kepler Rd., Deland, FL 32724.

### Article II PURPOSE

Rosewood Ecclesia is a Holy Spirit empowered church body that heals, equips and sends out mature believers as kingdom representatives, empowered with five-fold ministry gifts and the mandate to perform miracles, signs and wonders and to destroy the works of the enemy of God to prepare the Bride of Christ in all nations for the return of Jesus and the establishment of the New Jerusalem.

The church shall be limited to religious, charitable and educational activities within the meaning of Section 501 (c) (3) of the U.S. Internal Revenue Code.

### Article III STATEMENT OF FAITH

- We believe that the Bible is the God's undisputable truth and guidance for mankind. Man continues to rebel against God's truth, but God sent His son Jesus Christ to reconcile man back to God. The purpose of our prayer ministry is to bring all of us back God through repentance and forgiveness through Jesus Christ and the Holy Spirit.
- We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God. Rejection of one's biological gender is a rejection of the image of God within that person.
- We believe that God has commanded that no intimate sexual activity be engaged in outside of marriage between one naturally-born man and one naturally-born woman. We believe that any form of homosexuality, lesbianism, bisexuality, bestiality, incest, fornication, adultery, and pornography, are sinful perversions of God's gift of sex. We believe that God disapproves of and forbids any attempt to alter one's gender by surgery or appearance.
- We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ.
- We believe that every person must be afforded compassion, love, kindness, respect, and dignity. Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with scripture nor the doctrines of this ministry.

### Article IV POWER OF AUTONOMY

This church is autonomous, but advice and counsel from qualified ministers of other bodies of like principles and faith may be sought. The church is sovereign of Christ's headship, and all ecclesiastical power exercised by the church and decisions made by the Board of Trustees shall not be subject to change or reversal by any other ecclesiastical body.

# **ROSEWOOD ECCLESIA**

## **RESTATED ARTICLES OF INCORPORATION**

### Article V MEMBERSHIP REQUIREMENTS

The categories of membership, qualifications for membership and the manner of admission shall be as set forth in and regulated by the Bylaws of Rosewood Ecclesia.

### Article VI PROCEDURE FOR RESCINDING MEMBERSHIP

The procedure for rescinding membership shall be set forth and regulated by the Bylaws of Rosewood Ecclesia.

### Article VII BOARD OF TRUSTEES

Rosewood Ecclesia Board of Trustees is the governing body of the church. It consists of the following:

- Apostolic Overseer
- Apostolic Servant Leader
- Pastoral Care Servant Leader(s)
- Prophetic Worship Servant Leader(s)
- Evangelistic Outreach Servant Leader(s)
- Teacher Servant Leader(s)

The manner in which the Trustees are elected or appointed are designated in the Bylaws.

### Article VIII SIGNING AUTHORITY

The Apostolic Overseer has the authority to take appropriate legal and financial actions as determined by the Board of Trustees. This includes, but is not limited to,

- Serving as the Registered Agent for signing all statutory forms, filings, returns
- Signing all documents with respect to government requirements and sale of property
- Coordinating with other churches, agencies, and civil organizations to meet Rosewood Center objectives.
- In the case that the Apostolic Overseer is unavailable or unable to serve as the Registered Agent, the Apostolic Servant Leader will act as the Registered Agent.

### Article IX LIABILITY IDEMNICATION

Rosewood Ecclesia shall indemnify any person who is or was an employee, agent, representative, member of the Board of Trustees, or volunteer of the Church against any liability asserted against such person and incurred in the course and scope of his or her duties or functions within the Church to the maximum extent allowable by law, provided the person acted in good faith and did not engage in an act or omission that is intentional, willfully or wantonly negligent, or done with conscious indifference or reckless disregard for the safety of others. The provisions of this article shall not be deemed exclusive of any other rights to which such person may be entitled under any bylaw, agreement, insurance policy, vote of members or otherwise.

### Article X EARNINGS STATEMENT

The Rosewood Ecclesia is organized exclusively for religious purposes. Therefore, no part of the net earnings of the Rosewood Center shall inure to the benefit of, or be distributed to its trustees, directors, officers or other private persons, except that Rosewood Ecclesia shall be authorized and empowered to pay reasonable compensation for services rendered.

## ARTICLES OF INCORPORATION

### Article XI DISSOLUTION STATEMENT

Upon dissolution of the Rosewood Ecclesia assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future tax code.

### Article XII AMENDMENTS

The bylaws may be revised or amended by a majority vote of the Board of Trustees present and voting at any Board of Trustee meeting.


