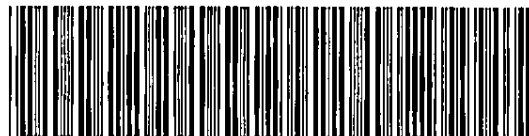

Amended Article III

The specific purpose for which this corporation is organized is: L.E.A.P DEVELOPMENT CORP INC IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCATIONAL, AND SCIENTIFIC PURPOSES INCLUDING FOR SUCH URPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS DESCRIBED UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

Added Article VIII

The duration of the corporate existence shall be perpetual until dissolution:

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 ( c )(3) of the Internal Revenue Code, or the cotTesponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
