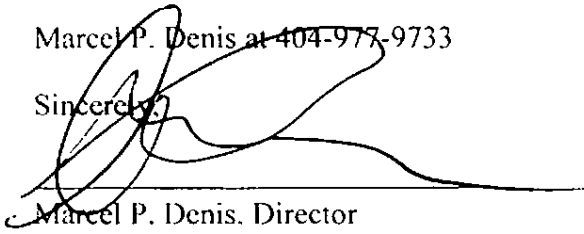

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation:

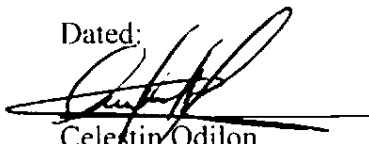
FRANCIUS WANCITO with address 13695 West Dixie Highway, North Miami, Florida 33161 is hereby removed as a director.

On Sunday, July 16, 2017, during a regular board of directors meeting Mr. Francius Wancito moved to have his name remove as a director and further indicated that he wishes not to remain involve with Citizens United for Progress. Mr. Wancito's motion was seconded and the board unanimously voted to honor and granted Mr. Wancito's request.

On Sunday, July 16, 2017, upon the motion of Marcel P. Denis, the board of directors unanimously voted to amend the articles of incorporation to reflect the removal of Mr. Wancito Francius's Name. There being no objection, the board adopted the present amendment removing Francius Wancito as a director.

The amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.
