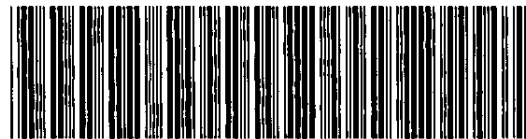



**ARTICLES OF INCORPORATION  
(Not for Profit)

**Article I – Name**

The name of the Corporation shall be Rodney Cain Ministries, Inc.

**Article II – Principal Office**

The principal address of the Corporation shall be:

**Article III - Purpose**

This Corporation is organized is to establish a Christian ministry whose essential purpose is to advance the Gospel of Jesus Christ and teach Biblical principles to others. In furtherance of the foregoing objectives and purposes, the Corporation will, on a regular and ongoing basis, teach and preach the Gospel, equip others to carry the message of God to others, help restore and build new ministries, motivate others to learn the Gospel and live according to a Biblically-based, Christian lifestyle, and to engage in such other activities that will further these objectives.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this Corporation shall be authorized
