## **Articles of Incorporation**

In compliance with Chapter 617, F.S. (Not for Profit)

### Article I Name

The name of the corporation shall be Ayudarlos Inc.

### Article II Principal Office

The principal street address is 5855 ne 43<sup>rd</sup> lane road, Silver Springs, Florida, 34488.

### Article III Purpose

Ayudarlos Inc. is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers not in furtherance of section 501(c)(3) purposes.

### Article IV Limitations

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal revenue Code), and this corporation shall not participate in, or intervene in (including publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

### Article V Dissolution

Upon termination or dissolution of Ayudarlos Inc., any assets lawfully available for distribution shall be distributed to one or more organizations which is organized and operated exclusively for charitable and education purposes and which has established its tax-exempt status under Section 501 (c)(3) that will be identified but the board of directors at the moment the organization formally dissolves.

### Article VI Manner of Election

The directors of Ayudarlos Inc, shall be elected in accordance with methods and qualification specified in the bylaws of the corporation. In no event, shall the number of directors be fewer than three.




