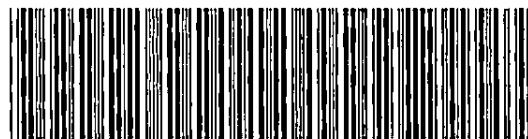

ARTICLE VIII BYLAWS




