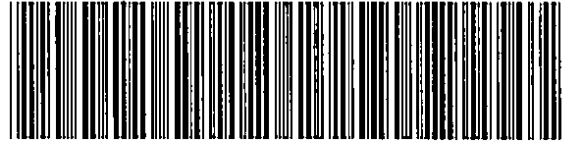



ARTICLES OF INCORPORATION

Your Salvation Matters, Inc. A Florida Not for Profit Corporation

The undersigned hereby executes these Articles of Incorporation for Your Salvation Matters, Inc., pursuant to the provisions of Chapter 617 of the Florida Statutes as set for the herein:

ARTICLE I - NAME

The name of the corporation shall be Your Salvation Matters, Inc., hereinafter referred to as "Matters", and its principal mailing address and place of business is 14359 Miramar Parkway, PMB 510, Miramar, Florida 33027.

ARTICLE II – PURPOSES

The Corporation is organized for the following purposes:

- 1.) Matters is organized and operated exclusively as a non-stock charitable organization for charitable, educational, scientific, and literary purposes, the promotion, publicity, and the making of distributions to organizations that qualify as exempt organizations within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and the regulations thereunder, as they now exist or as they may hereafter be amended (hereinafter collectively referred to as the "Code"), or the corresponding section of any future federal tax code..
- 2.) The mission of Matters is to provide education, advocacy, and supportive services in South Florida to individuals and their families needing spiritual direction and guidance when faced with challenges in everyday situations.
- 3.) Matters may have and exercise to the extent necessary or desirable for the accomplishment of any of the aforesaid purposes, and to the extent that they are not inconsistent with the charitable purposes, any and all powers conferred upon not for profit corporations by the Florida Not for Profit Corporation Act.

ARTICLE III - MANAGEMENT

All power and authority of Matters shall be vested in and exercised by its Board of Directors which shall manage and direct the affairs of Matters in accordance with applicable laws and as provided by the Bylaws of Matters. The number of Directors shall be as provided in the Bylaws for Matters, but the Board of Directors shall at all times consist of three (3) active members. The method of electing members of the Board of Directors shall be as provided in the Bylaws of Matters. The voting and other rights of the members of the Board of Directors shall be as provided in the Bylaws of Matters.

ARTICLE IV- INITIAL BOARD OF DIRECTORS

ARTICLE V – BYLAWS

Matters' Board of Directors shall adopt Bylaws for the regulation and management of its affairs. Matters' Bylaws may contain any provisions not inconsistent with the law or these Articles of Incorporation. Matters' Bylaws may be amended, altered, or repealed and new Bylaws may be adopted as provided in Matters' Bylaws.

ARTICLE VI – AMENDMENT

These Articles of Incorporation may be altered, amended, or repealed only by a majority vote of the Board of Directors of Matters.

ARTICLE VII – DURATION

Matters is to exist perpetually unless dissolved according to law.

ARTICLE VIII – LIMITATIONS

- 1.) No part of the net earnings, gains, or assets of Matters shall inure to the benefit of or be distributable to any Director or officer of Matters, or to any other private persons, or to any organizations organized and operated for profit, except that Matters shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.
- 2.) No substantial part of the activities of Matters shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by the provisions of §501(h) of the Code, if §501(h) of the Code applies to Matters and the appropriate election is made by Matters. Matters shall not participate in, or intervene in (including the publishing or distributing of statement) any political campaign on behalf of or in opposition to any candidate for public office.
- 3.) Notwithstanding any other provisions of these Articles, the Matters shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income taxation under §501(a) of the Code as an organization described in §501(c)(3) of the Code, or by an organization's contributions to which are deductible under §§170(c)(2), 2055(a)(2), 2106(a)(2)(A)(ii), and 2522(a)(2) of the Code.
- 4.) Matters, if it is a "private foundation" as defined in §509(a) of the Code at any time, shall distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Code §4942(a), and shall not:
 - a.) Engage in any act of "self-dealing" as defined in Code §4941(d), which would give rise to any liability for the tax imposed by Code §4941(a);
 - b.) Acquire or retain any "excess business" holdings" as defined in Code §4943(c), which would give rise to any liability for the tax imposed by Code §4943(a);
 - c.) Make any investment which would jeopardize the carrying out of any of its exempt purposes within the meaning of Code §4944, so as to give rise to any liability for the tax imposed by Code §4944(a); or
 - d.) Make any "taxable expenditures" as defined in Code §4945(d), which would give rise to any liability for the tax imposed by Code §4945(a).

The references in this Paragraph to designated sections of the Code shall be deemed to include any corresponding provisions of Federal Tax Laws at any and from time to time in force and effect during the continuance of Matters.

ARTICLE IX – DISTRIBUTION UPON DISSOLUTION

Upon the dissolution of Matters, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. The Board of Directors or a Court of Competent Jurisdiction in Florida, shall use its best efforts to make such distributions to organizations which have purposes similar to Matters.


ARTICLE X – INITIAL REGISTERED OFFICE AND AGENT

The name of the initial Registered Agent of Matters is La'Trese K. McPhee, Esq., and the address of Matters' initial Registered Agent is 3350 S. W. 148th Avenue, Suite 110, Miramar, Florida 33027.

ARTICLE XI – INCORPORATOR

The name of the incorporator is Darryl Avant, and the incorporator's address is 14359 Miramar Parkway, PMB 510, Miramar, Florida 33027.
