# Article III Purpose

BG BIKES BUILDING FUTURES, Inc. purpose as established by these articles of incorporation are those specifically designated in the Internal Revenue Code of 1986 section 501c(3), as amended or the corresponding section of any future federal tax law.

The specific purpose of BG BIKES BUILDING FUTURES, Inc. is as a Christian faith based youth development organization to receive and administer funds for the purpose providing education, guidance and life skills training in a loving encouraging environment to at risk children and to inspire each child's hope for their future as they experience the success found in applying these skills to everyday life. BG BIKES BUILDING FUTURES, Inc. program is designed to teach the knowledge required to understand the administrative/technical skills required of bike repair and maintenance while encouraging principles of self-confidence, creativity, social conduct, honesty, responsibility, trust and development of self esteem with Christian volunteers and mentor leaders. This program provides creative personal growth and leadership opportunities for youth as after school and summer programs that do not exist in the community of Belle Glade, Florida, while fostering success focused youth that will become productive members of society less inclined to become associated with gangs and criminal activity.

BG BIKES BUILDING FUTURES, Inc. may seek collaborations with churches and other charitable organizations in place and will otherwise operate exclusively for charitable, scientific or educational purposes within the meaning of Sec. 501 c (3) of the Internal Revenue Code of 1986, as amended (the "Code") of which operations:

- 1. No part of the net earnings of the Corporation shell inure to the benefit of, or be distributed to, its members, board of directors, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth herein; should BG BIKES BUILDING FUTURES, Inc. dissolve, its assets must be distributed for an exempt purpose to a charitable organization to be determined at that time.
- 2. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidates for public office except as authorized under the code;
- 3. Notwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Sec. 501 (c) (3) of the Code (or the corresponding provisions of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under sec Sec.170 (c)(2)of the code (or corresponding provisions of any future United States Internal Revenue Law).
