ARTICLES OF INCORPORATION

OF

TAMPA BAY MARINE CONTRACTORS ASSOCIATION, INC.

a Not for Profit Corporation being formed pursuant to Chapter 617, Florida Statutes

ARTICLE I

Name and Duration

- 1.1 The name of the Corporation Not for Profit is TAMPA BAY MARINE CONTRACTORS ASSOCIATION, INC. (hereinafter "the Corporation").
- 1.2 The Corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE II

Principal Place of Business and Mailing Address

2.1 The principal place of business and mailing address for the Corporation shall be 6111 142nd Avenue North, Clearwater, FL 33760

ARTICLE III

Purpose

3.1 The Corporation is organized exclusively as a trade organization within the meaning of § 501(c)(6) of the Internal Revenue Code as may be amended and its principal purpose shall be to benefit the member individuals and entities comprised of licensed marine contractors and individuals and entities affiliated with the marine industry (as determined by the Board of Directors) throughout the Tampa Bay area. The Corporation will provide its members services, communication and education

regarding the latest updates on legislation and technology relevant to the marine industry. The Corporation will also strive to assist its members on being competitive in the current business environment, as well as providing a forum for networking and a collective approach to monitoring and addressing issues important to the marine industry.

ARTICLE IV

Manner of Election of Directors

4.1 The directors of the Corporation shall be elected in accordance with methods and qualifications specified in the Bylaws of the Corporation. In no event, shall the number of Directors be fewer than three (3).

ARTICLE V

Initial Board of Directors

- 5.1 The Corporation shall have four (4) Directors initially.
- 5.2 The number of directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three (3).
- 5.3 The name and address of the initial directors of the Corporation are as follows:

ARTICLE VI

Initial Registered Office and Agent

6.1 The street address of the initial registered office of the Corporation is 6677 13th Avenue North, Suite 3A, St. Petersburg, FL 33710 and the name of the initial registered agent of the Corporation is D & B CORPORATE SERVICES, INC.

ARTICLE VII

Incorporator

7.1 The name and address of the person signing these Articles is:

ARTICLE VIII

Powers

- 8.1 The powers of the Corporation shall be provided in the Bylaws of the Corporation in accordance with Chapter 617, Florida Statutes with the following limitations within the meaning of §501(c)(6) of the Internal Revenue Code, as may be amended:
 - The Corporation must be an association of persons having some common business interest and its purpose must be to promote this common business interest;
 - 2. The Corporation must be a membership organization and have a meaningful extent of membership support;
 - The Corporation must not be organized for profit;
 - 4. No part of the net earnings of the Corporation may inure to the benefit of any private shareholder or individual;

- The Corporation's activities must be directed to the improvement of business conditions of one or more lines of business as distinguished from the performance of particular services for individual persons;
- 6. The Corporation's primary activity does not consist of performing particular services for individual persons; and
- 7. The Corporation's purpose must not be to engage in a regular business of a kind ordinarily carried on for profit, even if the business is operated on a cooperative basis or produces only sufficient income to be self sustaining.
- 8. The Bylaws of the Corporation shall adopt these provisions accordingly.

ARTICLE IX

Meetings

- 9.1 After incorporation, the appropriate members of the Corporation shall hold an organizational meeting in accordance with Chapter 617, Florida Statutes, as amended.
- 9.2 The Board of Directors of the Corporation may participate in a regular or special meeting by, or conduct the meeting through, the use of any means of communication which allows all directors participating to simultaneously hear one another. A director participating in such a meeting is deemed present at the meeting.

ARTICLE X

Indemnification

10.1 The Corporation shall indemnify its officers, directors and authorized agents for all liabilities incurred directly, indirectly or incidentally to services performed for the corporation, to the fullest extent permitted under Florida law for non profit corporations existing now or hereinafter enacted.

ARTICLE XI

Dissolution

11.1 Upon dissolution and upon payment or adequate discharge of all liabilities and obligations, the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of §501(c)(6) of the Internal Revenue Code, as amended, or shall be distributed to a State or the Federal government for a public purpose.
